Reverend Bob Neal gave the Invocation and Mayor Jerkins led the Pledge of Allegiance. Mayor Jerkins asked if any Council Member would like to add items to the Agenda. No items were added to the agenda.

Mayor Jerkins presented John "Ran" Forrister with a five year pin and thanked him for his efforts and hard work. Mayor Jerkins presented Sylvia England with a plaque and a fifteen year pin and thanked her for her hard work. Ms. England thanked the Mayor and Council for all their support. Mayor Jerkins presented Carolyn Duncan with a plaque and a ten year pin and thanked Ms. Duncan for all her hard work and thanked her for a job well done. Ms. Duncan thanked the Mayor and Council and her family for attending the meeting. Mayor Jerkins stated you really don't know how much you will miss someone till they are gone. ## 5. CITIZENS REPORT

Mayor Jerkins asked if anyone would like to speak to the Mayor and Council. Ms. Ann Turner stated her name and her address 5415 Austell-Powder Springs Road the house with the orange mailbox that is now resting on the fireplug because the flood pulled it out of the ground. I have heard that a tunnel is almost completed going from Maxham to Old Alabama and going to Discovery Blvd. It is supposed to be like twenty seven feet in diameter. Is this true or false? Mayor Jerkins stated yes, it is true but it is a sewer tunnel. Ms. Turner stated is there no tie in to the fresh water and the sewer tunnel. Mayor Jerkins stated, no, it will be all sewer and no fresh water. Mayor Jerkins stated he had been in the tunnel. Ms. Turner stated, so, the tunnel does exist. Mayor Jerkins stated, yes, it does. It is for the Cobb County Sewer lines and this is the second one they have built. The first one was eighteen feet and this one is twenty-seven feet which is huge and this is probably only twelve feet here. It is about a six mile tunnel and it costs three hundred and twelve million dollars I think. Ms. Turner asked have all the cities in the county separated the storm water from the sewer water? Mayor Jerkins stated all the water and sewer have always been separated from regular water. Ms. Turner asked all the storm drains in the street, they do not go into sewer. Mayor Jerkins stated, no, they don't. The problem with that they have to treat all that water and so if you put all of that in there they would have to treat it and it would cost them a fortune. Ms. Turner stated I bet no one thought to run another tunnel to parallel to it for the storm water to bypass Sweetwater or to alleviate the Sweetwater mess. Mayor Jerkins stated it has to go in the right direction and it would have to come back out into Sweetwater Creek. If you put a tunnel taking care of the part of Sweetwater Creek it needs to come out down there and it can go straight and Sweetwater can curve and do everything but if you put it under the ground it has to come out in the area where it can meet back into the creek before it gets to the Chattahoochee River. Ms. Turner asked, so it can't go directly into the Chattahoochee? Mayor Jerkins stated maybe it could but it would create problems. Ms. Turner thanked the Mayor. Mayor Jerkins asked if anyone else would like to speak to the Council.

Mr. Clinton McGill stated his name and stated he lived at 3030 Sunlight Drive, Mulberry creek subdivision.

I would just like to thank the Council for hiring Treasure Rogers who has been assisting with the buyout program. Almost ninety days ago I really didn't have a lot of hope about what was happening. Thank him for the professionalism along with Mr. Randy Bowens and Duane Demeritt. It has been a good process and I just wanted to acknowledge this because we have been so very critical in the past. We just need to let you know how much we appreciate his efforts. Mayor Jerkins thanked Mr. McGill. Mr. McGill stated he hoped they would provide some kind of status because I know the application is due January 19, 2010. Mayor Jerkins stated it takes some time to get all the information back. It may be March or June of this year. Mr. Bowens stated we are planning to have another status meeting with all the homeowners that have signed up.

Ms. Mercedes McGee stated her name and stated she lived in Mulberry Creek subdivision and I live on Sunlight Drive. I know we have asked this question over and over again but just in case in case there has been a change since the last meeting. Is there anything that can be done to avert the water that we had backed up into Mulberry Creek and the surrounding area? Where the bottleneck and what is is keeping the water from flowing freely. Because every time it rains it still backs up and they have to close Jones Road and our street and the bridge. Is there anything that can be done to get that water flowing so when it rains it want backup all the time. Mayor Jerkins stated it is basically sitting there and it can't get out. It circles around and hasn't much fall. Sweetwater Creek only has less than two feet per mile when it gets here. Once it leaves Austell on further down it has ten feet of fall per mile. So it is just sitting here and when it gets down there it starts going. Unless, they do put a tunnel in this is the only thing that can be done. There have been a couple of studies and you could cut the trees out but that would not lower it very much. It would not make any difference. Little can be done. Ms. McGee stated at the status meeting at the Threadmill a few weeks ago there had been mentioned a possibility of someone coming out and looking at the flood plain of Mulberry Creek. We have water all the time and I still have water behind my property and up the hill where the pond is my property stays wet all the time. I think because of all the rain and the erosion I don't think I am three feet above the flood plain and that is just me because of the situation I am in. Is there any way this can be looked at to see if the levels have changed and we are actually below the three feet. Mayor Jerkins stated some the residents will qualify for the buyout. Ms. McGee stated, yes, across the street from me. Mayor Jerkins stated they have a map that brings up every individual house and if that house touches the flood plain in AE zone and is more than fifty percent damage then it qualifies for the buyout and all of this is taking place. FEMA sets the rules and we cannot change that, they may change it later because of this last flood.

> Ms. Mercedes stated looking at the flood map they just kind of circled around Mulberry Creek where the flood plain is on that side and we have just been horseshoed out of it where all the water comes in. At some point, they need to look at this. Mayor Jerkins stated they are the ones that make the changes and we just go by this and basically they make changes for the insurance company. Mayor Jerkins asked if anyone else would like to speak to the Council.

There has been quite a bit of the over growth cleanup. Mr. Kimbrough asked Chief Williams if he had sent Ms. Williams notice of the initial hearing back in July and if she was present at that hearing. Chief Williams stated, yes, he did. Mr. Kimbrough asked Chief Williams if she had been sent notification of this hearing as well which she was well aware of this hearing back in July 2009. Mr. Kimbrough asked if she signed for the letter. Chief Williams stated, yes, she did. Mr. Kimbrough asked if anyone had any questions of Chief Williams. No one did.
